AMENDMENT PROPOSAL OF ARTICLE 12 OF THE STATUTES

Remco Koerts is welcoming everybody to the Extraordinary General Assembly and clarifies the purpose of the meeting. During the working session with the National Representatives in Split, Vice-President Ana Paula Pais worked with the Executive Board members on different subjects. Among other items, there was a brainstorm about a way to ensure involvement on the Presidium level of countries with a significant number of members within our association. Based on the input of the National Representatives, the Presidium prepared an amendment which has been sent to all members before this meeting.

Vice-President Ray Cullen presents the main aspects of the context of the amendment and the development process of the proposal to amend Article 12 of the AEHT statutes as set out below:

Additional Vice-President

- Currently a president and 5 vice presidents
- Additional vice president position open to a country which is member of the Council of Europe
- 100 plus schools
- 60 % (60 or more schools) AEHT paid members two months prior to the elections
- There must be more then 5 candidates for vice-president of the association

In other words, the additional Vice-President position would only concern countries, that are member of the Council of Europe, count at least 100 and more potential AEHT member schools of whom 60% must have paid their membership fees two months prior to the elections. Nowadays, several countries would be eligible for such a position. However, this additional post will only be created if there are more than 5 candidates running for the post of AEHT Vice-President.

The assembly proceeds to the voting with following result:

- IN FAVOR : 36 - AGAINST : 0

ABSTAINMENTS: 2

Despite the fact that all members present in the meeting are in favour, the proposal is nevertheless based on Article 18 of the AEHT statutes not legit:

Article 18 – Modification of the Statutes

"The statutes of the Association can be modified only by a proposal from the Executive Board or from the Presidium. The Extraordinary General Assembly, called to debate the proposed modifications, must consist of two thirds of the active members, either present or represented. Each member present can have only one properly drawn up proxy vote. If the meeting is inquorate, a second Extraordinary General Assembly is called within six weeks. This will be a valid meeting, whatever the number of active members present or represented. A majority of two-thirds of the votes of the members present or represented is necessary for the modification to be adopted."

We are therefore obliged to organize a second Extraordinary General Assembly within the next six weeks, for which our members will soon receive a new invitation. For this meeting the vote will be valid regardless of the number of members present or represented.

AMENDMENT PROPOSAL OF ARTICLE 12 OF THE STATUTES

The assembly starts with a welcome message by AEHT President Remco Koerts. He thanks the audience for joining this 2nd Extraordinary General Assembly and wishes everybody a Happy and Healthy New Year:

"I really wish for all of us that the development of the vaccines will lead us to the end of this terrible and complicated period. All of us feel the need to return to our 'normal' social lives. However, we have to hold on a bit longer but the prospects for 2021 are very promising.

The online Annual Conference in December showed us that despite the physical distance the AEHT spirit is very much alive. I am really looking forward to meeting you all in person again in 2021 and I am sure we will. As you know the two major AEHT events are scheduled for 2021: the Annual Conference in Tallinn and the Christmas in Europe event in Waterford. This perspective will provide the necessary energy we all need to cope with the challenges still ahead of us."

On the 3rd of December, during our AEHT Annual Online Conference, we organised the first Extraordinary General Assembly concerning the modification of Article 12 of the AEHT statutes. However, the quorum of two-thirds of the members required was not reached to consider the vote legitimate. This is why we have to hold a 2nd Extraordinary General Assembly with only this single item on the agenda.

As during the 1st Extraordinary General Assembly, Ray Cullen exposes the proposed amendment (see details in the minutes of the 1st Extraordinary General Assembly above).

The creation of the said additional Vice-President position will make sure that a very large and dynamic group of schools within a specific country will be represented at the Presidium level. However, this position will only be created if there are more than 5 candidates for the post of Vice-President and can only be held by an elected National Representative. As there is only one National Representative per country, it is not possible that two Vice-Presidents of the same country are entering the Presidium.

According to Ray Cullen, there are only benefits, no negative impacts, to be expected from this measure. An additional Vice President will provide extra support and input to our association. It will be a blessing for our association to have additional help in taking care of a large group of schools in a country.

This measure will also encourage a country to intensify the recruitment of member schools on its territory, bringing more funds to our association, which is currently in financial difficulties.

After all these clarifications, a vote is taken: 42 people are present, 33 votes are cast, of which 32 are in favour, none against and 1 abstained. 9 persons did not express a vote.

As a result, the proposed amendment is adopted by the General Assembly. The statutes will be changed accordingly.
